General Business: A) Minutes of the November 12, 2020 meeting were approved. Motion by Becky West second by Anne Frame, approved with a voice vote. Bills in the amount of \$11,125.97 were approved. Motion by Anne Frame, second by Jan Horberg. (roll call vote-8 yes, 0 no, Anne Mills arrived after the vote). C) The treasurer's report was filed. D) The Director's report was discussed and filed.

Unfinished Business: A) Modified library services will continue as is for now. B) As per the Per Capita requirements, the board discussed the chapters 3,4, and 5 of the <u>Serving Our Public 4.0 Standards for Illinois</u> <u>Public Libraries</u>.

C) Anne Frame moved to accept the Board Action Calendar and the library meeting calendar, Marc Adami second, passed with a voice vote. D) With a motion by Anne Frame and a second by Jan Horberg, Marc Adami was elected to serve another term as President, Melissa Nyboer was elected to serve another term as Secretary. Passed with a voice vote. E) The By-Law committee suggested that the board have a vice-president to serve if the president is not available. Becky West agreed to act as vice-president. F) Anne Frame moved to accept the 2020 Audit report, second by Jan Horberg, passed with a voice vote. G) Jessie Wroble moved to give treasurer Chris Vanderleest the authority to move the money currently in a CD at Community State Bank into a new CD that gives the best rate. Second by Becky West, passed with a voice vote.
